ENTRY REQUIREMENTS

Basic *English, Literacy, Numeracy and computer skills* are required to undertake computer/online work. Students will also require *access to a computer and internet*. Please note that job roles in the Age Care and health industry will require manual handling tasks and may require vaccination evidence.

FUNDING ELIGIBILITY

Students are required to have **completed** *CHC33021 Certificate III in Individual Support* (or superseded qualification) AND be an **Existing Worker** in the *Aged Care industry*, which includes parents and unpaid carers of NDIS participants. (Evidence required e.g. payslips with job title and description.)
